PROP 65 Compliance

- A warning symbol in yellow



- The word "WARNING" in all capital letters and bold print
- For products causing exposure to listed carcinogens, the statement: "This product can expose you to chemicals including [name one or more chemicals], which is [are] known to the State of California to cause cancer. For more information go to www.P65Warnings.ca.gov."
- For products causing exposure to listed reproductive toxicants, the statement: "This product can expose you to chemicals including [name one or more chemicals], which is [are] known to the State of California to cause birth defects or other reproductive harm. For more information go to www.P65Warnings.ca.gov."

For internet sales, the complete warning must be provided (i) on the product display page by displaying either the complete warning or a clearly marked hyperlink labeled "WARNING" that links to the complete warning, or (ii) by otherwise prominently displaying the warning to the purchaser prior to completing the purchase. A warning is not sufficient if the purchaser must search for it in the general content of the website, as has been a common practice.

For catalog sales, the warning must be provided in a manner that clearly associates the warning with the item being sold.

By testing products and placing the proper warnings we will ensure compliance with California Proposition 65 regulatory requirements.
